There is no current Mercy rule for Minnesota high school soccer.

Proposed Recommendation

We propose that in the second half, if the goal differential is 5 goals or more, the clock will only stop for serious injury.

Include any other policies that are impacted by this proposal.

We do not believe that this proposal would significantly impact any other policies. We would no longer have games (or at least lessen the number of games) that have scores with a goal differential in the double digits.

Rationale

What is the history of the proposal?

During Covid (2020-21), the change was made to end stopping the clock after goals when a team is losing by 5 or more goals. This extra time was thought to add unnecessary exposure during a clearly decided game. We polled our association members and coaches and received an 83% approval for a similar Mercy rule where the clock will continue to run after goals scored if a team is leading by 5 or more goals in the second half. The clock would only stop for serious injury. We want to try to eliminate games where the score is overly lopsided without taking away too many minutes from players and teams. In addition to this rule change, we will continue to encourage coaches to find creative ways to even the playing field to make a competitive game despite the uneven opponents.

This proposal will benefit all Minnesota students by providing all with an enjoyable competitive experience and we can avoid overly lopsided results.
