Rationale

What is the history of the proposal?

Dance has historically been a sport that has worked outside of the typical rules and contact period with regard to allowing a tryout in the spring for the following season.

Coaches have historically needed to establish the number of rostered participants on their team, and the language around choreography and the number of students allowed (prior to the start of the season) is based on the number of people on your team. So it has been important for coaches to have this information. It was also a typical process to order custom uniforms for each member, prior to the season. This process has changed as schools have developed the idea to order more uniforms than needed, to ensure that when additions are made at the beginning of the winter season, they have enough for other previously unidentified student athletes who would participate in the winter.

How does your proposal benefit education-based opportunities and MSHSL Mission and Beliefs for all Minnesota students?

Removing the spring tryout option will align dance with all of the other MSHSL sport opportunities that are currently only able to hold a tryout inside of the MSHSL designated season.

This tryout in the spring can be a reason that dance participation numbers are not always applicable to Title IX participation opportunities in state reporting.

Removing this option will provide a level of equity between programs, as some schools do not allow tryouts, as it is a conflict for those students who are involved in spring sports.

What other policies are significant in this proposal?

The season length and choreography time could be impacted by the proposal.

Provide evidence of support for the proposal from other groups

Generally, coaches understand that this will put them in alignment with each of the other sports offered by the MSHSL.

AD's would support this, as it assists in assuring that student athletes are not asked to participate in an out-of-season sport tryout during the time of their spring season.

Impact

This could lessen some of the inequity that tryouts can present to schools who may have student athletes participating in spring sports during the time of the required tryout period for dance.

Many schools have developed a practice of not allowing tryouts for dance because it puts students in difficult situations.

It could also address some issues around qualified student athletes and coverage under the MSHSL umbrella if students are not registered for dance during the tryout period.

It also eliminates the scenario where a student could be selected for the dance team and then changes enrollment prior to the start of a season.
