Proposed Recommendation

Submit your proposed change to the above-stated rule/policy.

- The application of a factor system to be put into place for all MN High School Nordic races including section and state meets for those athletes who have confirmed their Para classification with the U.S. Paralympics Nordic Team. Each athlete would need to complete basic certification through email communication with US Paralympic staff at uspnordic@gmail.com .
- These athletes would be placed and scored according to their factored time for all events.
- Every Para athlete would be given a 3% factor compared to their non-adaptive competitor, with the FIS Para Nordic standard factor applied on top of this 3%. Factors are taken from the FIS Para Nordic factor system with an additional 3% factor applied to their result time. This is to account for the high school races having primarily

non-adaptive racers vs FIS Para Nordic races where all the athletes are Para athletes. (See chart below. The chart reflects the total time deduction that would be made for high school races.)

- Para athletes would need to ski the same course as non Para athletes.
- A USPN representative will provide an update to MSHSL on any factor percentage changes done on the FIS Para Nordic level. Percentages will be reviewed and adjusted annually to be sure to reflect any changes in order to provide the most accurate andupdated percentages.
- Para skiers must comply with FIS Para Nordic rules during competition.

This proposal is consistent with the Leagues efforts to support persons with special disabilities. The United States Ski Association has long promoted para-competition in both Nordic and Alpine

events. There are mechanisms within the USSA that will assist in these efforts.

Rationale

What is the history of the proposal?

The League has a list of para activities within other sports. This effort is consistent with those efforts.

How does your proposal benefit education-based opportunities and MSHSL Mission and Beliefs for all Minnesota students?

This proposal would even/level the playing field for athletes who are skiing with impairments that inhibit their performance in Nordic Skiing.

 There were at least five skiers on High school teams in MN this season who raced on their team using one or no poles because of a limb difference. The application of the time factor for these athletes will allow them to compete fairly against all their peers who are using two poles. This system may also encourage other athletes with limb or vision differences to see the opportunity in Nordic skiing for them no matter their difference.
